  - iv. The Client shall not, enhance, delete or make any amendments to this agreement without the written consent of ***Helping Every Youth Magazine WaveMakers 2013***, which consent will not be unreasonably withheld.
  - v. The Client shall conduct himself/herself and require persons at the rental table with his/her consent to conduct themselves in a manner that will not contravene any law, bylaw, ordinance or regulation applicable in respect of the Premises, nor cause or permit any nuisance.
  - vi. The Client agrees to utilize the table rental for the purpose laid out in this agreement and any violation of these terms will be grounds for immediate termination of this rental agreement.
